We are excited to announce the 1st Chicago Bottle Clubs Show & Sale will be returning for our 4rd year to the Matteson Holiday Inn Conference Center, 500 Holiday Plaza Drive, Matteson Il. 60443. Our 48th Annual Show will be held on October 29, 2017 from 9a.m. to 2 p.m. The Holiday Inn Conference Center is carpeted, well-lit, and is perfectly located in a pleasant South-Western Chicago Suburb with easy access, just south of I-80 at the intersection of I-57 and route 30.

Double-Queen and King Rooms have been secured for show guests at the affordable cost of \$99.00. This includes amenities of a large indoor pool & whirlpool, premium channels and wired & wireless high speed internet. Bar Louie Restaurant is also located onsite. Reservations can be made by calling Holiday Inn direct at (708) 747-3500. Please make your reservations early as the Holiday Inn is always booked up. The rooms and the rate are only secured until Saturday October 7, 2017.

As with past shows at the Holiday Inn Conference Center, we will continue to reserve a generous portion of our floor space for displays. This year our theme will again be individual group displays. The informative and educational displays that comprise this year exhibits will contain some very rare and unique items. In some cases this may be a once in a lifetime glance at some outstanding pieces.

SHOW AND SALE CONTRACT

SUNDAY, OCTOBER 29, 2017 HOLIDAY INN MATTESON, ILLINOIS

1. The sales table rental is \$30.00 for each 6' x 2 1/2' table. Covers and a dealer sign will be provided for each table. Signed sales contracts must be accompanied by cash, check or money order in full payment made payable to the 1st Chicago Bottle Club.
2. Dealer unloading will be allowed on Sunday from 6:30 a.m. to 7:00 a.m. during which time merchandise may be placed under or behind tables. Only shelving or showcases will be permitted to be placed on tables during this time period. No dealing will be allowed during this period and your cooperation in this regard will be expected.
3. Dealer set-up time will begin at 7:15 a.m. and last until 9:00 a.m. Only dealers with identification badges will be allowed entry into the showroom during this period. The Club adheres to a strict **NO EARLY ADMISSION** policy and no member of the general public will be allowed in until 9:00 a.m. on Sunday.
4. Dealer identification badges will be limited to two persons per contract with the exception of minor children. These badges will allow admission to the show during set-up and public hours and must be worn at all times.
5. The types of merchandise that may be sold include the following: antique bottles, fruit jars, pottery, insulators, advertising and collectible items, quality table top antiques and books and magazines related to this merchandise. Every item must be clearly priced or marked "For Trade" or "Best Offer". Oiled, damaged, repaired or artificially coated items must be so marked. Color altered or irradiated items are not allowed. New or reproduction items that may confuse a prospective purchaser must also be marked. Remember that one of the purposes of the show is to promote our hobby by educating collectors with information and displaying fairness. The Show Chairpersons reserve the right to require the removal of any item from a table not in compliance with the terms of this contract.
6. Show time for general admission will be from 9:00 a.m. to 2:00 p.m. Each and every dealer is expected to stay until the end of the show and all sales tables must remain set-up and open to the public until 2:00 p.m., when the show ends. This policy is not only one of common courtesy to fellow dealers, but also one of fairness to the members of the public who have paid admission. Furthermore, do not ask the Show Chairperson to leave early because of personal circumstances. **THERE WILL BE NO EXCEPTIONS TO THIS POLICY.** Any violators will not be invited to participate in future shows.
7. Your signature on the attached contract indicates agreement with the rules herein and understanding that the 1st Chicago Bottle Club, its Show Chairpersons, and the Holiday Inn, Matteson assume no liability or responsibility for lost, stolen or damaged property or injury of any kind.
8. Cancellation of this contract with a full refund will be accepted until October 22, 2017.
